## **EPR Programs in Vermont**

KAREN KNAEBEL & MIA ROETHLEIN, VERMONT DEPARTMENT OF ENVIRONMENTAL CONSERVATION

What is EPR? How does it provide convenient and safe collection opportunities for hard to manage materials? Who are the various players in creating a successful EPR system? This presentation will provide an overview of the five Extended Producer Responsibility programs in Vermont. Karen and Mia will share successes and lessons learned.



**Karen Knaebel** has worked for the State of Vermont for over 20 years with the Mercury Education and Reduction Campaign for mercury product and EPR laws as well as oversight of the Electronics (E-Cycles) EPR program that has been operational in the state for over 10 years.



**Mia Roethlein** has worked in the world of materials management and waste reduction for almost 20 years and is especially interested in household hazardous waste and product stewardship. Mia's favorite place to be is anywhere outside in nature and is very grateful to live in VT.

## **CDPHE Recycling Grant Programs**

#### SONYA HANSEN, CDPHE

The State of Colorado offers funding opportunities statewide and targeted within the Front Range through its Recycling Resources Economic Opportunity (RREO) and Front Range Waste Diversion (FRWD) programs. Grant funds support projects that reduce waste and champion recycling in Colorado through a cadence of recurring Requests for Applications (RFAs). This presentation will provide a high-level overview into the two programs and will highlight upcoming funding opportunities as well as example projects funded by the programs.

The world is moving aggressively towards zero carbon solutions, and batteries are at the center of all of it.
